1. Call to Order & President's Introduction

URA past-President, Peter Miasek called the meeting to order at 8:20 pm. Peter welcomed members, guests and elected officials.

2. Approval of 2018 Annual General Meeting Minutes

Members reviewed and approved the November 05, 2018 AGM meeting minutes.

3. President's Report

In his report Alick thanked the members, Councillors and Board of Directors for contributing to URA's 2019 accomplishments. Alick highlighted several achievements, such as the York Downs development settlement and the comprehensive list of subject-matter-expert speakers. Since 2019 was a federal election year, URA's contribution to candidates' meetings and overall electoral participation was also acknowledged.

4. Treasurer's Report

Treasurer, Donna Day provide the following highlights for fiscal period starting August 31, 2018 and ending on September 01, 2019. Please see appendix for details.

- 1. Revenue
 - Revenue for 2019 was \$1,675 5% increase over 2018

2. Expenses

- Expenses for the year were \$1,675 an increase of 41% over the previous year
- Most of increase is attributable to more frequent use of the Pan Am meeting venue and web hosting fees
- Onetime expenses included fees for the URA name change
- 3. Heritage Funds Restricted
 - Balance remains unchanged from 2018 at \$2,029
- 4. Bank Balance
- Funds available for operations is \$5,432.61. A 12% or \$982.86 decrease from 2018
